### **Information for Families**

A person's 'career' is their journey through life, learning and, where appropriate, work. Every person's career will be different, but our aim is to support our pupils with learning the skills and knowledge to move beyond the school into a meaningful lifestyle where they are happy with how they spend their time, have an active part in their local community and have a good standard of living.

Within school, pupils take part in a range of timely activities presented according to their individual needs. This ensures that they are well informed and able to play an active part in determining their future pathways post school.

This guide is to assist parents with the steps to be taken to support their child as they move through the school to ensure a smooth transition into adult life beyond Frank Wise.

School staff endeavour to understand the challenges faced by parents and carers and will support you throughout your child's time at school to help to determine their best options for the future.

Young people in England are required to stay in education until the age of 18. This may be in full time education (6th form or college), on an apprenticeship / traineeship or in part time education accompanied by paid work / volunteering.

### YEAR 9

Year 9 is a good time to start helping your child to think about their future.

From school year 9, the annual review will include a focus on preparing for adulthood.

Areas discussed will continue to include eduction, health and community inclusion.

However, from this review onwards, choices for after Frank Wise will also be considered including employment and independent living.

Help your child think about their strengths, abilities and what they enjoy	The year 9 annual review is when targets will be discussed to begin planning and preparation for adulthood.

Check and update the All About Me child's perspective for your child's EHCP	Classes will work directly with the children on this in either the Autumn or Spring terms. Teachers will liaise with families over the content and parents will ultimately have the final say on whether the school version or one that they themselves would rather produce gets put forward for the update at Annual Review. This must be decided by the end of May.
Agree EHCP outcomes in line with moving into adulthood at the annual review meeting	This is a significant review for your child where aspirations and plans for adulthood will begin to be discussed.
	School will support with updating your child's EHCP and will help with ensuring that the outcomes planning that is introduced in this review reflects their aspirations for adult life.
Open a bank account for your child	Open a simple debit card bank account jointly in the child's name. Seek advice from your bank on an account that can transfer to your child once they reach adulthood.

### YEAR 10

At the year 10 annual review, you will be asked to name your child's preferred choice of education provider for post 16 learning. This change will not commence until after they have completed year 11, but planning begins a year in advance. At the end of year 11 your child will have the choice to remain at Frank Wise school and move into the Griffiths Centre sixth form, or move on to further education elsewhere. They may also have an option to pursue a supported internship.

Young people are expected to stay in education until the age of 18 years. Special educational needs provision is available for longer if required (up to the age of 25 years) if your child can be seen to be making progress.

Open days are a good way to explore what is on offer, both in terms of the course and support available for your child. Some examples of courses are below.

### YEAR 11

At the end of school year 11, there is a choice on whether to remain at school or move onto education elsewhere. All young people must stay in some form of learning until the age of 18 years.

Once a young person reaches the age of 16 years, provided they have the mental capacity, the right to make requests and decisions is now theirs, rather than their parents (Part 3, Children and Families Act 2014, Mental Capacity Act 2005).

### YEAR 12

Even though young people have just arrived in the GC, we will begin planning with them and their families ready for leaving Frank Wise school.

Apply for a student bursary if appropriate	If your research has determined the best option for your family is for your child to apply for benefits in their own right and they are entitled to New ESA (Employment and Support Allowance) and PIP (Personal Independence Payment), apply for a student bursary. 	Inform annual review meeting of thoughts on post 19 choices, and the general decisions that have been made such as type of education provider, living arrangements etc.

#### YEAR 13

At the end of this school year the Transition Annual Review will take place.

Students should be ready to state where they want to go to after Frank Wise by the year 13 Transition Annual Review.

When firming up on what's next, consider all of the outcomes from the EHCP. Think about eduction and health, but also community inclusion and keeping in touch with friends, routes to employment and living arrangements. Will a young person remain in the family home or move to residential college or supported living?

In the Autumn term, complete any final visits to place that your child may wish to move onto after Frank Wise.	As decisions are finalised, keep school and your child's SEN Officer informed of your plans, especially if you are considering out of county placements. Discuss ideas for post 19 provision with class teacher and OSLO at the December termly review meeting. Further support to help with visits / decision making can be provided if needed.
	Be clear as to why your choices will provide the best outcomes for your child, and why other options aren't suitable.
	When making decisions, try to look forward to where your child would like to be after their next destination.
Inform annual review meeting of firm decision on post 19 destination.	Your choices for your child's next destination can be recorded in the parent / carers section of the EHCP report. This will inform the local authority SEN team when they begin to consult with colleges abut whether the college can offer a place early in year 14.
	Local college is the most straight forward case where funding for continued education and the provision of transport should continue. The SEN Team have a statutory duty to ask if the local college feels that they can meet your child's educational needs as this is likely to be the most cost effective option (and they are using public money). However, if you and your child feel that the best option for your child is elsewhere, a clear explanation will be required along with why a local option would not be considered suitable.
	It is important to keep in touch with the SEN Officer during this year as this may enable you to agree the desired destination for your child without a need for challenging decisions and a possible tribunal later in the process.
When your child turns 18, their social care will move from the children's	If your child has a social worker, this transition should begin around the time that they reach 17 and a half years old.
disability team into the moving into adulthood social care team.	A social worker from the moving into adulthood (MIA) team will meet with you and complete an assessment to determine the package of support that your child will receive once they become an adult.
Health care (including therapy services) will move to the adult health team.	The MIA social worker will also support the family alongside the SEN officer and school with what your child's day to day life will consist of once they leave school.

#### YEAR 14

Your child is now in their final year at Frank Wise school. This school year will have an emphasis on supporting them to move onto their next destination (transition).

School staff will support individual students alongside staff who will be supporting them wherever they will go to next. This often includes staff from colleges visiting students at Frank Wise and then Frank Wise staff supporting students for transition sessions with whichever provider the student will move on to.

During the Autumn term the SEN team will consult with colleges and other providers to check that they are able to meet your child's needs.	<ul> <li>Having a clear plan as to where your child would like to go next is vital for this process to run as smoothly as possible.</li> <li>The SEN team will often consult with more than one possible provider for your child. They then have a statutory duty to update your child's EHCP with the name of their next education provision by the 31st of March in the year that they will leave Frank Wise.</li> <li>The SEN team will work with the moving into adulthood social care team to determine funding for education, transport and the other support (such as clubs, activities and support from care services) that your child will require.</li> </ul>
During this year, your child will complete a CV with information about themselves ready for moving on from Frank Wise.	<ul> <li>Where appropriate, students will complete work experience placements as independently as possible during this year.</li> <li>Where appropriate, families are encouraged to seek work experience or part time work for their child using their own community contacts. Work on independent travel training will continue to promote as much independence as is appropriate within the local community	Independent travel training will continue to build upon skills developed in years 12 and 13. The aim is for each student to be as independent as possible in getting around the local community before they leave school. These skills can be supported outside of the school day.
